PROCEDURE - REGARDING RELEASE OF MOVABLE/IMMOVABLE PROPERTY DOCUMENTS ON REPAYMENT/SETTLEMENT OF LOANS

- i. The loan taken by the borrower will be considered closed only upon full repayment of the principal amount of Loan, interest thereon and/or all other Dues payable in terms of the Loan Agreement executed between borrower and the Berar Finance Limited (hereinafter referred as "the Company").
- ii. The Company will issue the No Objection Certificate (NOC) and release all the original movable/Immovable property documents to the Branch Office from where loan was serviced or from the Head Office, as per the preference of the borrower (mentioned in Sanction letter/ welcome letter issued on or after December 01, 2023) and remove charges registered with any registry within a period of 30 days after full repayment/ settlement of the loan account.
- iii. If the borrower is unable to personally visit the branch office or Head office of the Company, then the original property documents will be handed over to the borrower's legal representative or nominee by issue of Letter of Authority in favour of the legal representative. (Format as per Annexure 1)

PROCEDURE FOR RELEASE OF ORIGINAL MOVABLE/ IMMOVABLE PROPERTY DOCUMENTS TO THE LEGAL HEIRS ON DEMISE OF THE BORROWER:

In the event of sad demise of the Borrower(s), the legal heir(s) of the deceased Borrower(s) will be required to reach out to Berar Finance Limited ("hereinafter referred to "Company") at a preferred branch or head office. The legal heir(s) will have to submit following documents to process the request:

- i. Death Certificate of Borrower.
- ii. Request letter by Legal heir(s) of deceased Borrower for release of original immovable property documents/ moveable property/No Objection Certificate (NOC) as the case may be.
- iii. Legal Heirship certificate of Borrower or Succession Certificate issued by the competent authority. *(mandatory only in case of MSME Loan or Loan Against Property (LAP))*
- iv. Self-attested KYC document(s) of all Legal heir(s).
- v. Such other documents as specified by the Company from time to time.
- vi. In case of the release of original immovable property document/moveable property/NOC, to any one of the legal heir, then all the other Legal Heirs shall jointly submit their request or issue letter of Authority in favour of one or more legal heir(s) of Borrower, to the Company as per the format (Annexure 2).
- vii. Affidavit cum Undertaking as per the format (Annexure-3)
- viii. Any delay on non-submission of relevant documents on the part of the legal heirs/claimants in the contingent event of demise of Borrower, it shall not be constituted as delay on the part of the Company.
