"Reinsurance premiums are exempted from GST, but distri-

bution costs on direct sales of individual policies are not. We are preparing a joint represen-tation on behalf of life insurers," Kamlesh Rao, chairperson of the Life Insurance Council's Insurance Awareness Committee, told in an interview.

It must attain a minimum net worth of \$25 crore by the end of the third financial year of granto fauthorisation. To conduct business, promoters and directors of the company should clear the "fit and proper criteria as mandated by the regulator. Additionally, the Righ has urged PA to form a dispute resolution mechanism to resolvelissues related to transactions and put a strong risk management systemin place to prevent fraud and assure customer protection.
